**CITY OF AURORA
PARKING RULES AND REGULATIONS**

1. PERMITS ARE GOOD AT ANY TEN (10) HOUR METER UNLESS OTHERWISE RESTRICTED.
2. PERMIT MUST BE DISPLAYED OR VEHICLE WILL BE TICKETED.
3. PERMIT DOES NOT GUARANTEE HOLDER A SPECIFIC TEN (10) HOUR METER LOCATION OR LOCATION OF HOLDER'S PREFERENCE.
4. PERMIT DOES NOT ALLOW PARKING AT METERS OF SHORTER DURATION OR IN AREAS OTHERWISE RESTRICTED UNDER ANY CIRCUMSTANCES. PARKING AT SHORTER TERM METERS WILL REQUIRE INSERTION OF APPROPRIATE COINAGE.
5. VEHICLES PARKED UNDER THIS ARRANGEMENT FOR MORE THAN TEN (10) CONSECUTIVE HOURS AT ANY TEN-HOUR METER WILL BE SUBJECT TO PARKING CITATIONS.
6. ALL RESERVED PERMIT PARKING SPACE RENTAL PAYMENTS MUST BE PAID IN FULL (ON A CALENDAR QUARTER BASIS) PRIOR TO THE BEGINNING OF A NEW CALENDAR QUARTER.
7. BILLING WILL BE ENFORCED UNLESS NOTIFICATION OF CANCELLATION IS RECEIVED IN WRITING BY THE MOTOR VEHICLE PARKING SYSTEM. REFUNDS WILL BE ISSUED ON A PRO-RATED BASIS (INCREMENTS OF HALF MONTH) MINUS A TEN DOLLAR (\$10) ADMINISTRATIVE FEE FOR HANDLING THE REFUND
8. ANY CHANGE IN VEHICLE MAKE OR CHANGE IN LICENSE NUMBER MUST BE REPORTED BY CALLING THE CITY OF AURORA AT **(630) 256-3580**. FAILURE TO DO SO MAY RESULT IN THE ISSUANCE OF A CITATION AND/OR THE REMOVAL OF THE VEHICLE FROM THE LOT.
9. PERMITS AND PASSCARDS ARE NOT TRANSFERABLE.
10. FOR PURPOSE OF LOT MAINTENANCE, YOU MAY BE REQUESTED TO PARK IN AREAS OTHER THAN THE SPECIFIED PARKING AREA BY THE MVPS DEPARTMENT.
11. UNREGISTERED, UNLICENSED, ABANDONED OR INOPERATIVE VEHICLES WILL BE REMOVED AT OWNER'S EXPENSE.
12. AUTOMOTIVE REPAIR WORK IS NOT PERMITTED ON THE PREMISES OF ANY LOT.
13. THE CITY OF AURORA RESERVES THE RIGHT TO CANCEL/REVOKE ANY RESERVED PERMIT PARKING TO AN APPLICANT WHO IS IN VIOLATION OF ANY CITY ORDINANCE AND HAS FAILED TO CORRECT THEM WITH FIFTEEN (15) DAYS OF NOTIFICATION.
